## **COVID-19 BOLD PANTRY GUIDELINES FOR RECEIVING ITEMS**

- 1. The Cora-Dian Cameron Heart of Hope Extended, Inc. (CDCHOHE) reserves the right to pray and have a few moments of reflection before distributions begins.
- 2. Distribution to the public will be on announced at least 1 day before and will operate from 1/2pm until 5pm OR per current COVID-19 Safety Advisory from the Governor of Maryland.
- 3. **Recipients are asked to CALL FIRST (240-554-5432 / 240-241-0415)** to schedule a pickup. No walk-ins allowed at this time. Registration is required (name, number of household members and contact info.) Kindly remain in your cars and drive-up to receive items as directed by Special Services Unit at Lighthouse Ministries International.
- 4. Items for distribution may be parceled or prepacked. Persons will be served from their vehicles. Please note, some items will have a limit to the quantity you can receive, please follow instructions or signs posted.
- 5. BOLD PANTRY will provide boxed items, you do not need to bring your own shopping bags.
- 6. You are required to be respectful at all times to those who will be assisting you. You are not entitled, remember, *BOLD* is a courtesy offered to you through generous donations from those who have a heart of compassion for those in need.
- 7. You are not permitted to go into any other areas of the church building, only to the designated areas for the distribution of the food items, identified by staff. Please remain in your cars and follow the directions of traffic officers. We do not provide public bathrooms.
- 8. It is not compulsory, but you are free to leave a donation for the *BOLD* Pantry Program. Your donations will assist us with managing and continuing this free program of support to the community.
- 9. The Cora-Dian Cameron Heart of Hope Extended, Inc. Bread Of Life Distribution Program and our facility Lighthouse Ministries International (LHMI) will not be responsible after you have willingly and voluntarily taken the distributed items each time you visit our facility. Take hampers/pantry items at your own risk. The distribution items taken are final and are not returnable. The BOLD Program, CDCHOHE and LHMI are not responsible for any items you take from *BOLD* Pantry in/on and after you have left the BOLD Program area at LHMI.
- 10. You are required to follow the rules and guidelines of the Pantry above. Failing to do so, unfortunately will result in loss of your Membership Card and you will not be accepted into the Pantry for at least 2 years.
